ESTIMATED COST OF ATTENDANCE FOR F-1 AND J-1 STUDENTS

For an Initial or extended Form I-20, you will need to provide proof of funding to ISSS for your tuition, fees and living expenses while in the U.S. The amount will need to cover at least one year or until the academic term of your program completion, whichever comes first.

The funding can come from different sources:

Student's Personal Funds

Provide a letter* from the student's bank, on bank letterhead, addressed to the University of Miami **or** a bank statement issued by their bank. Online printouts are not accepted.

Funds from the University of Miami

Provide a letter* from the University department sponsoring the student, on letterhead, stating the exact dollar amount of assistance and specifying the type of assistance and the award period.

Funds from Family or Private Sponsor

- a) Provide a letter* from a bank, on bank letterhead, addressed to the University of Miami. If not indicated on the bank letter, provide a letter* from the family or private sponsor indicating that the funds in the account will be used to support the student.
- b) Provide a bank statement issued by the bank. Online printouts are not accepted. Provide a letter* from family or private sponsor indicating that the funds in the account will be used to support the student.

Government or Agency Sponsor

Provide a letter* from the government or agency sponsoring the student on their letterhead, addressed to the University of Miami, stating the amount of assistance and award period.

* The letter must be signed or stamped and guarantee the availability of sufficient funds to cover tuition and fees and living expenses for the duration of the stay or one year. Funding documents must be no more than six months old. Documents in a language other than English must be accompanied by certified English translations. Notarized translations alone will not be accepted. Translations supplement but do not replace original documents. Please remember to submit both.

The information below represents the Estimated Cost of Attendance (COA) at the University of Miami. Undergraduate, graduate, and law students have different rates. Other programs may have special rates, as published by the academic department. A student's individual COA could be different based on their program, length of program, enrollment, and actual charges.

Refer to the proof of funding of your educational level to determine the amount of funding you will need to demonstrate:

Undergraduate

Undergraduate COA based on 12 credit hours of enrollment per academic semester. Tuition expense will be prorated for students enrolling less than full-time in their last semester. Summer COA is contingent on Summer Enrollment.

Graduate

Graduate COA based on 9 credit hours of enrollment per academic semester. Tuition expense will be prorated for students enrolling for less than 9 credits or who are enrolled in an 800-level course. Summer COA is contingent on summer enrollment or academic term length (refer to *Financials* information on your Form I-20). Students who have a Graduate Assistantship/Stipend will need to submit proof of funding for 12 months or until the term of their program completion, whichever comes first.
